

**NATIONAL, STATE, AND LOCAL ORGANIZATIONS ASK CONGRESS TO
END ATTACKS ON IMMIGRANTS AND TO WORK FOR STRONG AND
INTEGRATED COMMUNITIES IN AMERICA**

November 2008

Dear Member of Congress:

We, the undersigned organizations, write to express our concern about legislative proposals in the 110th Congress that have threatened access to essential public services for immigrants and citizens. Services and benefits like public housing and health care programs, Social Security, and the Earned Income Tax Credit provide an important safety net for many working families. These programs already have requirements in place to ensure that federal dollars do not support restricted benefits for persons who lack citizenship or a satisfactory immigration status. Moreover, in many cases federal law requires even lawfully-residing immigrants to endure a five-year waiting period before accessing safety-net programs providing health coverage, nutrition assistance, and income support that are available to citizens in our communities.

However, lawmakers seem preoccupied with a notion that undocumented immigrants are improperly receiving federal benefits. In recent years we have seen a proliferation of false allegations about immigrants' access to services coupled with legislative attempts to restrict immigrant participation in important federal benefit programs. Some of these restrictions have come in the form of onerous identification requirements that are administratively burdensome and costly for states to implement with little or no evidence that they are even needed to prevent ineligible immigrants from getting the benefits. Instead, these requirements have their greatest impact on citizens and qualified legal immigrants who, while eligible for benefits, cannot receive them because they cannot gather the documents necessary to establish proof of their eligibility.

As Congress moves into a time of new opportunities and change, we call upon you and your colleagues to resist politically-driven proposals designed to appear tough on immigrants. We are concerned both about the consequences that these proposals have on access to services for eligible beneficiaries, and about the divisive impact that these negative debates have on our communities. Targeting the working poor with measures that may drive them deeper into poverty, especially in this time of grave economic crisis, is not an acceptable approach to fixing America's broken immigration system. We want solutions that promote strong, integrated communities and that are aligned with mainstream American values of compassion and integrity. We urge you to resist and speak out against unnecessary and misguided efforts to divert attention from the real problems we face and must solve together.
