UnidosUS (formerly known as NCLR):

As the largest national Hispanic civil rights and advocacy organization in the United States, UnidosUS works to build a stronger America by creating opportunities for Latinos. Since its founding in 1968, they've worked to promote the economic advancement of Latinos and to protect their civil rights. UnidosUS has played a leadership role in building opportunity through education, tax credits for working families, housing, access to health care, and defending the rights of immigrants. Through its network of nearly 300 affiliated organizations, they reach millions of Hispanics each year. They played a key role in successfully advocating for legal status for young immigrants who entered this country illegally (the "Dreamers"), have worked to improve conditions for poultry and agricultural workers, and are fighting for immigration reform.

National Immigration Law Center:

NILC is a leading organization in the US exclusively dedicated to defending and advancing the rights of low-income immigrants. For the past 38 years, NILC has won landmark legal decisions protecting fundamental rights, thwarted regulations that would have resulted in millions of workers losing their jobs, and advanced policies that reinforce and promote equality, opportunity, and justice. Advocates across the country rely on NILC's work to provide them with the tools and information they need to shape their own advocacy efforts. This year NILC has remained vigilant against any attempts to violate the constitution by limiting the civil rights of immigrants.
